This Addendum addresses the following changes/additions/deletions for the above referenced project:

ITEM	DESCRIPTION
1.	It looks like they wanted the roof to stay under 13' 9" and ours would be a few inches over 14' as seen below. And then they wanted to sidewall height to remain under 44'1" so I had to reduce my original bin by two rings, therefore it decreased the level bushel capacity to 82k, however, the peak bushel capacity still meets their ask with 91k.
	Response: The capacity of the bin is required to be 90,000 bushels; it is up to the vendor/supplier to accommodate this requirement within the confines of their bin design.
	The heights and dimensions supplied on the drawings outline an envelope that the supplied equipment must fit within.
2.	
	Regarding Drawing Sheet S302 call outs "Remove organics and fill down to undisturbed soil. Backfill with Structural Fill Per Specifications S12000 Prior to Installation of Aggregate Piers".
	1.Specification does not contain info about removal/replacement of any unsuitable soils. The nearest boring to our work location for new bin footing appears to be B-15 taken in the July 2014 Geotech report by QTI. Bore B-15 does not indicate any fill material in this location. Is the intent of this note only to remove +/- 4" of topsoil? If over-excavation and backfill with suitable soils is required please indicate the limits and to what depths of replacements are required.

Response: Base bid should assume 2'-6" of top soil and granular fill excavation to accommodate the new foundation slab bottom elevation as shown in 3/S302.

A signed copy of this Addendum is to be included with the Bid Proposal indicating that Bidder has read and understood the modifications made to the Bidding Documents. Bidder shall also indicate this Addendum within Article 3.01.A of the 00410 - Bid Form.


